

COVID-19 Update July 2020

As described in the government guidance, [Actions for early years and childcare providers during the coronavirus \(COVID-19\) outbreak](#) (updated 2 July 2020):

'Settings are also responsible for planning and implementing appropriate protective measures to reduce coronavirus (COVID-19) transmission. Section 3 of this guidance sets out the public health advice which early years settings must follow. It also includes the process that should be followed if anyone develops coronavirus (COVID-19) symptoms while attending. This guidance has been developed with advice from Public Health England (PHE).

*'These measures make up a 'system of controls', described in section 3, building on the hierarchy of protective measures that have been in use throughout the coronavirus (COVID-19) outbreak. We are keeping the protective measures under review, in line with the latest scientific advice.'**

Therefore, providers can either choose to update their policies in line with the 'systems of controls', or use them as a separate procedure, as provided here.

'The system of controls provides a set of principles and if settings follow this advice, they will effectively minimise risks. All elements of the system of controls are essential. All settings must cover them all, but the way different settings implement some of the requirements will differ based on their individual circumstances. Where something is essential for public health reasons, as advised by PHE, we have said 'must'. Where there is a legal requirement, we have made that clear.'

'System of controls

This is the set of actions early years settings must take. They are outlined in more detail below.

Prevention:

- 1) minimise contact with individuals who are unwell by ensuring that those who have coronavirus (COVID-19) symptoms, or who have someone in their household who does, do not attend settings*
- 2) clean hands thoroughly more often than usual*
- 3) ensure good respiratory hygiene by promoting the 'catch it, bin it, kill it' approach*
- 4) introduce enhanced cleaning, including cleaning frequently touched surfaces often using standard products, such as detergents and bleach*
- 5) minimise contact between groups where possible*
- 6) where necessary, wear appropriate personal protective equipment (PPE)*

Numbers 1 to 4 must be in place in all settings, all the time.

Number 5 must be properly considered, and settings must put in place measures that suit their particular circumstances.

Number 6 applies in all specific circumstances.

Response to any infection:

7) engage with the NHS Track and Trace process

8) manage confirmed cases of coronavirus (COVID-19) amongst the setting community

9) contain any outbreak by following local health protection team advice

Numbers 7 to 9 must be followed in every case where they are relevant.'

Local outbreak of COVID-19

In the event of a local outbreak of coronavirus (COVID-19), the government will take action to control the spread of the virus. As has occurred in Leicester, people in the affected area may be asked to stay at home as much as they can and not travel unless essential. Summary of procedures we are undertaking during covid-19 at St Clements

On arrival

- Social distancing markers in corridor for waiting parents.
- Limiting 3 adults in corridor at one time.
- Limiting 1 parent per child at drop off/pick up times.
- All parents to wear masks when in the setting unless exempt.
- All parents to use hand sanitizer before they enter the nursery.
- All children and staff members have their temperature taken on entry, anyone with a temperature above 37.5 degrees will be sent home.
- Anyone displaying symptoms of Covid-19 will be sent home.
- Parents are signing daily confirming that no one in their house is displaying Covid-19 symptoms.
- Staff sign daily confirming that no one in their house is displaying Covid-19 symptoms.
- We go through a checklist for telephone calls relating to illness/absence and ensure we are keeping a log of absences.
- All children wash their hands upon entry to the nursery and at regular points during the session. This is supervised to ensure it is done thoroughly.

Throughout the session

- Encourage good hygiene practises, promoting Catch it, Bin it, Kill it.
- Enhanced cleaning regime, regular cleaning of frequently used touch points.
- Toys reduced/limited in playrooms to ensure resources that have been used are cleaned.

- Each room has a maximum allocated number of adults at any one time, the door will be clearly marked with this number.
- Staff are encouraged to use hand sanitiser and wash their hands frequently during the day.
- Staff are encouraged to use face masks when the setting is busier such as during drop off and pick up times.
- When appropriate windows will be opened to maximise natural ventilation.
- Appropriate PPE available in each station(room) to be used when required.

In case of a positive test

- Ensure procedures are followed when someone in setting tests positive, i.e. contact local Health Protection Team.
- Engage with Track and Trace

Visitors

- Following our visitor's procedure during Covid-19 including taking details for the purposes of Track and Trace that are destroyed 21 days after visit.
- Viewings and visits are by appointment only.

There is a full risk assessment available in each setting. All procedures are subject to the latest guidance and will be updated accordingly.
